On Dec. 26, 1996 at approx. 0635 hours I received a phone call at my home phone number from Det. Sgt. Robert Whitson. Sgt. Whitson informed me that officers were on the scene of a reported kidnapping. The reported kidnapping had occurred at 75515 th St . located in Boulder, Boulder County, Colorado. JonBenet Ramsey, a 6 year old female, was reported to have been kidnapped from her home. JonBenet's mother had found a ransom letter inside the home at approx. 0550 hours this morning. JonBenet had last been seen inside her home at approx. 2200 hours on Dec. 25, 1996. There was no apparent forced entry to the residence. Other family members who were inside the home from the night of Dec. 25 through the morning of Dec. 26 had not been harmed. These family members included JonBenet's mother, father, and brother.

In the note left by the reported kidnappers, the author of the note stated the reported kidnappers would phone the Ramseys between 0800 hours and 1000 hours. Sgt. Whitson requested that I respond to the Ramsey address on 15 th St. Sgt. Whitson was going to make attempts to have US West Communications place a trace on all incoming calls placed to the Ramsey home.

I went to the Boulder Police Dept. and obtained a hand held tape recorder as well as my notebook. I met with Det. Fred Patterson at the Boulder Police Dept. (BPD). Det. Patterson and I responded to the Ramsey address located on 15th St. While at the BPD, I briefly met with BPD Ofc. Karl Veitch. Ofc. Veitch informed me that he had the ransom note which had been left by the reported kidnappers. I requested that ofc. Veitch make 3 copies of this note. This request was carried out. I retained possession of one of the copies of the note, another copy was given to Det. Patterson, and the third copy was placed in a seal envelope and left on my desk. I quickly reviewed the contents of this 3 page note. Det. Patterson and I then responded to the Ramsey residence. Prior to arriving at the residence we met with Watch III Sgt. Paul Reichenbach. We met with Sgt. Reichenbach at the rear of the Basemar shopping center at approx. 0755 hours. Sgt. Reichenbach personally provided us with the following additional information:

[^0]"decapitated." The $21 / 2$ page note had been found by JonBenet's mother (Patsy Ramsey) at the bottom of a spiral staircase located in the house.

John Ramsey is the president of Access Graphics. This business is located at 1426 Pearl St. in Boulder. This business is very successful.

Sgt. Reichenbach said there was a light dusting of snow on the ground when he arrived at the Ramsey residence. Sgt. Reichenbach did not notice any footprints or other tracks in the snow. Sgt. Reichenbach personally checked the exterior of the Ramsey residence. Sgt. Reichenbach did not notice any signs of forced entry to the residence.

Sgt. Reichenbach had arranged through Boulder Regional Communications Center (BRCC) dispatcher to have a trap placed on the Ramsey home phone number. The home phone number for the John Ramsey residence is (303) . Dispatcher had spoken with an employee with US West Communications. The trap was activated and in place by the time Det. Patterson and I arrived at the Ramsey residence. Sgt. Reichenbach informed me that US West Communication would need a "letter of demand" on BPD letterhead within 48 hours, explaining the necessity for this trap.

Sgt. Reichenbach had informed us that Boulder County Sheriff's Dept. (BCSD) Dep. Scott Williams was a canine officer. Dep. Williams was notified that his services may be needed, and was placed on standby. Sgt. Reichenbach also suggested that if a bloodhound's services were needed, Aurora police Dept. might be able to assist.

Det. Patterson and I arrived at the Ramsey residence at approx. 0810 hours. I personally met with BPD ofc. Rick French. Ofc. French provided me with a synopsis of who was on the scene and what had already been done. BPD crime scene investigator officers Barry Weiss and Sue Barcklow were also at the Ramsey residence. Ofc. Weiss was photographing the interior and exterior of the residence. Ofc. Barcklow was attempting to obtain latent fingerprints. Areas checked included: possible points of entry and exit to the residence; as well as the spiral staircase leading from outside JonBenet's bedroom to the first floor; and the door leading into JonBenet's bedroom. Ofc. French provided me with the following information:

Ofc. French told me that when he arrived he met with Patsy Ramsey, JonBenet's mother. Patsy was very upset and distraught and it was difficult for ofc. French to obtain information from her. Ofc. French also spoke with John Ramsey, JonBenet's father. Ofc. French learned that the

Ramsey family had been at a friend's house on the late afternoon and evening of Dec. 25, 1996. They returned home at approx. 2200 hours on Dec. 25. JonBenet and her brother, Burke, went to bed shortly after the family returned home. John Ramsey had read to JonBenet after she'd gone to bed, and before she went to sleep. JonBenet had last been seen wearing a red turtleneck and white long underwear. Patsy woke up this morning and discovered the suspected ransom note at the bottom of the spiral staircase. Patsy originally thought that the note may have been left by the housekeeper. Ofc. French had been told that the Ramsey family had been planning to leave early this morning for Michigan. The Ramsey family has a home in upper Michigan. After Patsy discovered the note she went to JonBenet's bedroom. Patsy discovered JonBenet was missing.

Ofc. French told me there was no apparent forced entry to the Ramsey home. Ofc. French had checked the Ramsey home and had not detected any sign of JonBenet. Four friends of the Ramsey's had been notified by the Ramseys of JonBenet's disappearance and were currently at the house. The pastor from the Ramsey's church had also been notified and was also present at the house. BPD Victim Advocates had been notified and were also present inside the Ramsey home.

After I had briefly met with Ofc. French I met with John Ramsey. I informed John Ramsey that US West Communications had already placed a trap on incoming phone calls made to his home. I told Mr. Ramsey that I would also like to connect a tape recorder to the incoming phone line. John Ramsey gave me his verbal permission. I asked John Ramsey for the location of the phones in the house, on the first floor. John Ramsey showed me a telephone mounted on the wall at the west end of the kitchen, and a telephone located in the den. The den is located west of the kitchen. I connected the tape recorder to the telephone located in the den. I informed Mr. Ramsey that if the author of the suspected ransom note called, we would be able to tape record the conversation. John Ramsey was informed of my actions and gave his verbal consent. After the phone recorder had been connected to the telephone in the den, I instructed John Ramsey on the use of the tape recorder. John Ramsey told me that he would answer the phone for all incoming calls.

After the tape recorder had been connected to the telephone, I met with Patsy Ramsey. Patsy was sitting on a chair in the sitting room. This room is located at the southeast corner of the house on the first floor. Two of Patsy's friends were with her, and $\longrightarrow$ Patsy spoke softly when she talked to me. At times Patsy seemed to be staring off into the distance. Patsy seemed to have a vacant look, and seemed dazed. Since Patsy was situated in a room at some distance from the den, I had limited contact with her. I asked ofc. French to remain with Patsy. I did
ask Patsy a few questions and was able to receive some information. The following is information I received from Patsy:

Patsy had gotten up on the morning of Dec. 26, 1996 and had gone down the stairs from her bedroom to the kitchen. Patsy used the back (i.e. west) stairway. The back stairway consists of a spiral staircase leading from just outside JonBenet's bedroom to the northwest corner of the first floor of the house. At the bottom of this spiral staircase patsy discovered a 3 page handwritten note. The note had been written on legal pad sized paper. Patsy said she originally thought the note might have been left by her housekeeper. After Patsy looked at the note and read it she ran to JonBenet's bedroom. JonBenet was missing.

I asked Patsy who had keys to her home. Patsy said the woman who was responsible for housekeeping at her home, an, had a key to the home. I asked Patsy if the home had an alarm system and if the alarm system had been activated on the night of Dec. 25. Patsy told me that the home does have an alarm system, however it had not been used for awhile. Patsy did tell me that she believed the house had been locked when she and the rest of her family went to bed on the night of Dec. 25. Patsy said she had not received any suspicious phone calls nor hang up phone calls in the past few weeks. There had been no unwelcome solicitors nor suspicious persons at the Ramsey home in the past few weeks.

Patsy said that she, her husband, JonBenet, and Berke (her 10 year old son) had planned on leaving Boulder on the morning of Dec. 26. The family was going to fly to Michigan to spend time at their summer home. I asked Patsy who knew about this trip. Patsy said some of her close friends knew, and the housekeeper knew. Patsy had not arranged for the neighbors or anyone else to watch their home while the Ramsey family was in Michigan.

I asked Patsy if she could think of anyone who might be responsible for JonBenet's disappearance. Patsy told me that her housekeeper, had asked to borrow money on Dec. 24. Patsy told me that she had had a Christmas party at her home on Dec. 23. was supposed to clean up from this party on the morning of Dec. 24. Iinda Hoffman had phoned Patsy on the morning of Dec. 24. Linda Hoffman asked Patsy if she could borrow some money. Patsy had said yes. Patsy told me she had loaned money to in the past. phoned patsy again on the afternoon of Dec. 24 . was crying. said she needed to borrow $\$ 2,000$. Patsy thought the money was needed for dental repair for and her family. Patsy told that she would write a check for $\$ 2,000$. Patsy said she would leave the check on the kitchen counter. Patsy told
me that was scheduled to be at the Ramsey home on Friday morning, Dec. 27, at 0900 hours.

Patsy told me has worked as her housekeeper for about the past 2 years. cleans the Ramsey home twice a week. Ms is paid $\$ 200$ a week. Patsy told me that Ms husband Patsy provided me with Ms husband's name, Patsy also supplied me with Ms home phone number, 2. Patsy further told me that Ms madn adult children have had problems in the past 2 months. Patsy believed that one of Ms adult daughters had been in contact with Safe House because of domestic violence problems. Patsy did not know the name of this daughter, nor where she lived. Patsy thought the daughter lived in Patsy thought the adult daughter's domestic problems might have occurred prior to Thanksgiving of 1996.

After I had spoken briefly with Patsy I returned to the den area of the house. Each time the telephone rang I was present when John Ramsey answered the phone. There were at least 3 times when John Ramsey was not present in the den when the phone rang. I personally saw John Ramsey run to the den to answer the phone. For each incoming phone call received at the Ramsey home on the morning of Dec. 26, John Ramsey told me that the caller was not associated with the suspected ransom note.

While $I$ was in the den the pastor from Church in relayed a message to me. Patsy had told this information to the pastor. I believe the pastor's first name was

The pastor told me about a telephone conversation Patsy had had with her mother. Patsy's mother had spoken with the housekeeper () while Patsy's mother had been living in the Ramsey home. Ms had reportedily said that JonBenet was so cute that someone would kidnap her. I met with Patsy and asked her about her telephone conversation with her mother. Patsy told me that she had spoken to her mother after she had discovered JonBenet was missing. Patsy's mother is c. lives in Atlanta, GA. had told Patsy that Ms man had said "many times" that JonBenet was such a beautiful girl, and wasn't afraid that someone was going to kidnap her. Patsy supplied me with home phone number. This home phone number is

Det. Patterson was going to follow-up on information regarding Ms and her family. Det. Patterson was going to attempt to have US West Communications place a trace on Ms home phone number.

Within about the first 20 minutes of arriving at the Ramsey residence $I$ asked John Ramsey if he would consent to having his office telephones have a trap placed on them. John Ramsey did give
his verbal authorization. John Ramsey supplied me with the work number for himself, as well as his first assistant. These phone numbers were: hen and respectively. Arrangements were made through US West to have a trap placed on these two phone lines at Access Graphics.

There were 2 cellular phones at the Ramsey house when Det. patterson and I arrived. These cellular phones were used to make phone calls from the Ramsey residence. The telephone at the Ramsey house was not used to make outgoing phone calls on the morning of Dec. 26. The cellular phones belonged to John Ramsey and . The friends who had been contacted by the Ramsey's, and who were present with the Ramseys when I arrived, were: and ; from ind Church in Boulder. Burke, the Ramsey's 9 year old son, had already left the residence when I had arrived. Burke was staying at the home located at in Boulder.

After I had connected the tape recorder to the telephone, and had briefly met with Patsy Ramsey, I talked with John Ramsey in the den. I talked with John Ramsey about things to say when the author (s) of the suspected ransom note called. I told John that he should demand to talk to JonBenet. If John Ramsey was going to be given instructions for meeting the purported kidnappers, I instructed John Ramsey to obtain very specific instructions from the caller. John Ramsey was told to say that he would not be able to obtain the money until at least 1700 hours this date. I supplied John Ramsey with a piece of note paper. I had John Ramsey write notes on this piece of paper regarding what to say when the author (s) of the suspected ransom note phoned. I retained this notebook paper and later placed it into evidence (item 4LKA). The third item written by John Ramsey was "must talk to JB." I had placed an asterisk by this sentence.

[^1]friends of the Ramsey's and the pastor divided their time between Patsy and John. John Ramsey paced between the area of the den and the formal dining room. John was usually by himself. I did not see John or Patsy interact with each other. No one in the house made any obvious comment to me that it was after 1000 hours and the suspected kidnappers had not called. From the time I arrived at the Ramsey house until approx. 1000 hours I had a few brief conversations with John. I had asked John if the doors to the house had been locked when the family went to bed last night. John etold me that he personally checked all of the doors and all of the windows in the home this morning. All of the doors and windows were locked. John told me that although the house does have an alarm system, the family has not used the alarm system for months. I asked John who had keys to the residence. John told me his adult son has a key to the house. The son had been in Atlanta since Dec. 15, 1996. The adult son, John Andrew, had been attending college at the University of colorado - Boulder. Another family member, Patsy's mother, also had a key to the residence. Patsy's mother is currently living in Atlanta, GA. I asked John if any keys had been hidden outside the house. John told me there were no hidden keys. I asked John of any keys had been lost or stolen. John told me there had been no stolen or lost house keys. John told me that the housekeeper, did have a key to the house. was the only person living in Colorado who had a key to the Ramsey house.
John Ramsey told me that he and his family had been at a dinner party held at the Dec. 25 , 1996. John, Patsy, Burke, and JonBenet had returned home at approx. 2200 hours. John told me that Patsy and Burke immediately went to bed. John had read a book to JonBenet, tucked her into bed, then John went to bed. John said he went to bed at approx. 2230 hours.
John told me that he is the President and CEO of Access Graphics. There was an article in the Boulder Daily Camera newspaper within this past month about Access Graphics. The news article had been written because Access Graphics had just grossed over $\$ 1,000,000,000$. John told me that Access Graphics has over 300 employees. John told me that Access Graphics resulted from a merger of 3 businesses in the mid-1980s. John Ramsey had been the founder of one of these businesses. John's business had been in Atlanta, GA at the time. John informed me that Access Graphics has business offices located in Mexico City, Mexico and Amsterdam.

I asked John if he could think of any past, or current, employee of Access Graphics who might be responsible for the disappearance of JonBenet. John told me he was not directly responsible for hiring or firing. John talked about the employees at Access Graphics as being all part of a family. John did tell me that there was one employee that he was forced to "let go" approx. 5 months ago. The name of this employee is John said that and his
wife,
told me he had not seen
company. John told me he could not think of anyone with whom he had disagreement with.
I asked John which interior lights, if any, were on when he went to bed on the night of Dec. 25. John told me no interior lights were on when he went to bed. I asked John which exterior lights were on when he went to bed. John told me that he didn't know if any exterior lights were on. John said the Christmas lights located in the front of the house may have been left on, and possibly an exterior light. There are small white Christmas lights lining the sides of the sidewalk extending toward the front of the house. These Christmas lights were on when I first arrived at the Ramsey residence.
After had been named as a possible suspect, I asked John if he had any photos of in the house. John Ramsey told me that he had a roll of film in his camera. Pictures had been taken of the Christmas party held at the Ramsey home on Dec. 23. John told me that had attended that party. I asked John for the film from that camera. John personally provided me with the film from that camera. I gave the roll of 35 mm film to ofc. Barry Weiss. I instructed ofc. Weiss to have the file developed ASAP. I asked John if he had any paperwork in the house which might contain handwriting. John checked the kitchen area for any note, but did not locate any. I asked John if he had cancelled checks which had been endorsed by did have copi. John phoned his bank. John was told that the bank by, have copies of checks which had been written to, and endorsed to me in care of the fax number located at the BPD Detective Bureau. This fax number is (303)

I asked John and Patsy for current photos of JonBenet. I explained that the photos would be copied and distributed to local law enforcement agencies. I was given two $8 \times 10$ photographs of JonBenet as well as and $8 \times 10$ portfolio of JonBenet containing 2 pictures and her physical description. I gave these photos to ofc. Barry Weiss and instructed him to have copies made and to relay the copies to Sgt. Larry Mason at the Boulder Police Dept. Ofc. Weiss and ofc. Barcklow cleared the Ramsey residence at approx. 1015 hours.
At an unknown time between approx. 0900 hours and 0945 hours Det. Sgt. Robert Whitson arrived at the Ramsey residence. Sgt. Whitson talked with John Ramsey in the den area of the house. I was present during part of this conversation. Sgt. Whitson informed John Ramsey that the FBI had been notified and was assisting in this investigation. Sgt. Whitson told John Ramsey that we would need a sample of his handwriting. John verbally agreed to supply Sgt. Whitson with a handwriting sample. Shortly after Sgt. Whitson had requested this sample, John Ramsey wrote and line on a legal
pad in front of him and signed his name to this pad. I was sitting next to John Ramsey when he wrote this. John has written "Now is the time for all people," then signed his name. I removed this sheet of paper from the legal pad, secured it in my notebook, and later placed it into evidence (item 4LKA).

Before ofc. Barry Weiss left, I asked him to show me what areas of the house he had processed for evidence. The first floor glass door located on the north side of the house, east of the spiral staircase, had been processed for latent fingerprints. John Ramsey had told me that this was the only door in the house that did not have a dead bolt to secure it. The spiral staircase located at the northwest corner of the house, extending from the first floor to the second floor, was processed for latent fingerprints. There was a green Christmas garland covering the handrail portion of this staircase. At the top of the spiral staircase was an open laundry area. JonBenet's bedroom door was located south of this laundry area. Ofc. Weiss walked to the patio door located at the south end of JonBenet's bedroom. Ofc. Weiss told me that there had been frost on the patio when officers had arrived. The frost had not been disturbed. Det. Patterson had entered JonBenet's bedroom. I walked into JonBenet's bedroom, only as far as the first bed. I did not touch anything. Ofc. Weiss pointed out a bedroom located west of JonBenet's bedroom. I entered into this bedroom a few steps, but did not touch anything. Ofc. Weiss then walked east along the second floor hallway into the children's playroom area. I noticed that there was a life size Barbie doll standing next to the north window. The doll was not clothed. Continuing east down this hallway there is a bathroom located on the north side of the hallway and a smaller bedroom located across from this bathroom. At the east end of the hallway is Burke's bedroom. Outside of Burke's bedroom is a stairway leading upstairs to the master bedroom. The stairway also leads downstairs to the front door. I walked upstairs into the master bedroom. I did not touch anything in the master bedroom area. I returned to the second floor using the west steps. The west steps enter the second floor area just east of JonBenet's bedroom, and just east of the open laundry area.

Sgt. Whitson requested that the door to JonBenet's room be sealed. Prior to his arrival, the door to JonBenet's room had been closed but not locked. I obtained a police crime scene tape and adhesive tape from Sgt. Whitson's vehicle. Det. Patterson and I sealed the entrance to JonBenet's room at approx. 1030 hours. At approx. 1035 hours all BPD officers, detectives, and victim advocates cleared the Ramsey residence. The only persons remaining in the residence were: John Ramsey, Patsy Ramsey, $\quad$, and myself.

I talked with John briefly after all of the officers had left. John told me that he and Patsy had been married 16 to 17 years. Patsy had been diagnosed with ovarian cancer 3 years ago. Patsy recently discovered that she was free of cancer. John's adult
daughter had been killed in a car accident 4 years ago. I asked John if there had been any suspicious people at his residence within the last few weeks. John told me no. I asked John if he had received any suspicious phone calls or hang up phone calls within the last few weeks. John told me no.

John Ramsey,
the den area talking at an unknown time after 1040 hours. I had placed my copy of the suspected ransom note on the table in the den and had asked John to review the note. I had asked John Ramsey to tell me what unusual things he detected from reading the note. John Ramsey said very little. John Ramsey's friends asked me my opinion of the note. I told John Ramsey's friends that the note appeared to be directed towards John Ramsey. The note also appeared to be personal, as it referred to John Ramsey as "John" throughout the note. John Ramsey's friends made the following observations about the note: The author of the note directed the note to John Ramsey; the amount of $\$ 118,000$ was an odd amount; the author of the note appeared to be somewhat educated, since the words "hence" and "attache" were used; the sentence "don't try to grow a brain John" seemed to be a slap in the face to John Ramsey; the closure "Victory! S.B.T.C." did not make sense; and the reference to John Ramsey being a southerner indicated to the friends the person did not really know John Ramsey because John was originally from Michigan. I asked John Ramsey if he had given a loan to anyone in the amount of $\$ 118,000$. John said he had not. I asked John if he owed $\$ 118,000$. John said he did not.

At an unknown time between approx. 1040 hours and 1200 hours John Ramsey left the house and picked up the family's mail. I was not present when John left. I did witness John Ramsey opening his mail in the kitchen. also left the Ramsey home. left sometime after 1015 hours. told me he had also taken photos of the Christmas party held at the Ramsey's home on Dec. 23. left to have his film developed at a one-hour photo lab. returned within about 30 minutes to an hour. At approx. noon Patsy relocated to the den area. Patsy laid down on the couch in the den. remained with Patsy. also stayed with Patsy. , and John Ramsey were in the kitchen area and formal dining room area of the house. Patsy asked me what we (i.e. police) were doing. I told Patsy that we were attempting to locate I also told Patsy that the FBI was involved in this investigation. Patsy had asked me these questions when I initially spoke with her. Patsy talked with me about the suspected ransom note. Patsy told me that did did not use the language contained within the note. Patsy explained to me that did not use the words "hence" or "attache" case. Patsy did not know why someone would ask for the amount of $\$ 118,000$. Patsy said that amount had no significance to her. Patsy asked me why the author of the note had not asked for a larger sum of money, or at least a round sum of money. Patsy said the author of the note referred to John as being
a Southerner. Patsy told me that anyone who knows John Ramsey knows he's not from the South. I asked Patsy when was next scheduled to be at their home. riday Dec 27 was due to be at the Ramsey home at 0900 hours on Friday, Dec. 27. While I was talking to Patsy she would repeatediy start crying. Patsy would be unable to speak. Patsy repeatedly asked "why didn't I hear my baby?" Patsy looked physically exhausted. Patsy would close her eyes, but was not able to rest or sleep.

When I talked briefly with John Ramsey during the morning of Dec. 26 he was able to carry on a conversation and articulate his words. John Ramsey had smiled, joked, and seemed to focus during the conversation. Patsy seemed to be much less focused when I spoke with her. Patsy seemed to have a far-off look in her expression. Patsy's thoughts were scattered and it was difficult to get her to stay focused on one thought. Patsy would collapse in tears and repeatedly asked why had she not been able to hear her baby. There were 2 phone calls received by John Ramsey when I saw him act differently than he had all morning. When he received each of these phone calls, John stood in front of the north door located between the den and the kitchen. John looked outside during the phone call. John told the caller that jonBenet had been "kianapped." John was sobbing and had difficulty speaking. At times, John was unable to speak. I was told by friends the identity of the 2 callers. One caller was John Ramsey's son, John Andrew Ramsey. The other caller was John Ramsey's daughter, Melinda Ramsey. John Ramsey told me that his Boulder family was planning on flying to Michigan this morning. John's adult children from another marriage, John Andrew and Melinda, had taken the family's private plane from Atlanta and had flown to Minneapolis, MN. John Ramsey, Patsy, JonBenet, and Burke were going to fly to Minneapolis, MN and meet with John Andrew and Melinda. The 6 Ramseys were then going to fly to their summer home located in Charlevoix, MI. They were going to return to Boulder on Sunday, Dec. 29.

At approx. noon I paged Det. Sgt. Mason and asked that he phone me at the cellular phone number for one of the phones at the Ramsey house. Patsy Ramsey had been repeatedly asking me for an update. At approx. 1230 hours I again paged Det. Sgt. Mason and asked him to phone me. I did not receive a call from either of these pages. At approx. 1230 hours I noticed that John Ramsey seemed to be by himself. John Ramsey was alone in the formal dining room area of the house. John Ramsey seemed to isolate himself from others. Earlier in the morning, I noticed that when John Ramsey was sitting down, he would look down and his leg would be bouncing. At an unknown time between 1230 hours and 1300 hours I talked with Wind that I needed his help to keep John Ramsey's mind occupied. I suggested to that he and John Ramsey check the house "from top to bottom," excluding JonBenet's bedroom. I suggested to that John Ramsey check to see if anything belonging to JonBenet had been taken or left behind. told me
that he had reported his daughter missing to the Boulder police Dept. this past year. had checked the house and found his daughter inside the house. said his daughter had been hiding. told me it was hard for him at that time not to be able to do anything. I then spoke to John Ramsey. I suggested to John Ramsey that he and check the house "from top to bottom" to see if anything belonging to JonBenet had been taken or had been left behind. I talked with John Ramsey in the kitchen of the house. After I had spoken to John he immediately went to the basement door. I saw following John Ramsey. I then returned to the den area. The time was approx. 1300 hours.

At approx. 1301 hours I received a page to phone BPD number . There was no answer. I had tried to make this call using one of the cellular phones at the house. I then returned to the den. At approx. 1305 hours I saw run from the area of the basement door to the den. I heard some type of shout or scream before I saw grab the phone in the den, dial 2 to 3 numbers, then hang up the phone. then ran back towards the basement door. yelled for someone to call an ambulance. I followed to the basement door. The door to the basement was wide open. I was standing in the hallway, facing the door to the basement, when I saw John Ramsey coming up the final three or four stairs. John was carrying a young girl in his arms. The young girl had long blonde hair. John Ramsey was carrying the young girl in front of him, using both of his arms to hold her around her waist area. The young girl's head was above John Ramsey's head while he was carrying her. From a distance of approx. 3 feet, as John was walking up the stairs, I was able to make the following observations to this young girl: both of her arms were raised above her head and were motionless; her lips appeared blue; her body appeared to have rigor mortis; there was a white string attached to her right wrist; there was a bright red mark, approx. the size of a quarter, at the front of her neck; the lower portion of her neck and the right side of her face appeared to have livor mortis. I told John to place the young girl's body on the rug just inside the front doorway. John did as he was instructed. The young girl was JonBenet. JonBenet appeared to have been dead for a period of time. I touched JonBenet's neck in an attempt to locate any sign that she was alive. JonBenet's skin was cool to the touch. There was dried mucus from one of JonBenet's nostrils. My face was within inches of JonBenet's face. I detected an odor of decay. John Ramsey asked me if JonBenet was alive. I don't remember the specific words John Ramsey used. I told John Ramsey that his daughter was dead. John Ramsey moaned. I told John Ramsey to go back to the den, where the other persons in the house were congregated. I told John Ramsey to phone 911 and have detectives and a coroner respond. I told John Ramsey to go to Patsy.

After John Ramsey left I picked up JonBenet and carried her into the living room. I laid JonBenet on the rug located inside the
living room. I noticed that JonBenet was wearing long white cotton pajama-like pants. JonBenet was also wearing a long sleeved white cotton or knit top. JonBenet's face was turned to her right side. There were no coverings on JonBenet's feet. JonBenet's feet appeared to be white (i.e. drained of color). I did not notice any marks to her feet. Shortly after I had moved JonBenet into the living room I heard a loud guttural moan and wail coming from the den area of the house. The noise sounded as though it was made by a woman.

John Ramsey came into the living room area approx. 1 to 2 minutes after I had sent him back to the den. As John entered the room he asked me if he could cover up JonBenet. John grabbed a throw blanket that was lying on a chair located immediately inside the living room. John placed this blanket over JonBenet's body before I had a chance to speak. I adjusted the blanket on JonBenet's body so that her clothing was covered from her neck down. I also covered the neck area of JonBenet. I had covered the wound on JonBenet's neck with her long sleeved shirt before John Ramsey arrived in the living room. I told John Ramsey that he could say good-bye to his daughter, but he could not move her body, touch her hands, or lower the blanket. John knelt on the floor next to JonBenet. John repeatedly referred to JonBenet as "my little angel." John stroked JonBenet's hair with one of his hands. John Ramsey laid down next to JonBenet, placed an arm around her body, and made sounds as though he was crying. I did not notice any tears. John Ramsey then rolled away from JonBenet's body and went into a kneeling position. When John rolled away from JonBenet's body he looked around, towards the hallway. John Ramsey then knelt by JonBenet's body, hugged her, and called her his little angel. After approx. 5 to 10 seconds John stopped hugging JonBenet and again looked toward the hallway. John remained kneeling near JonBenet when I looked into the hallway, towards the den. I was able to watch JonBenet, John Ramsey, and the people coming from the den toward the living room. I saw Patsy Ramsey. It seemed as though patsy was unable to walk without the assistance of someone on each side of her, holding her up. Patsy, into the living room area. When Patsy saw JonBenet's all came immediately went to her and laid on saw JonBenet's body she modiately wer JonBenet from the hallway, John Ramsey was to the right of her body, was near JonBenet's head, Patsy Ramsey was next to feet), and and was next to Patsy (near JonBenet's portion of JonBenet's body. left the living room and went into the kitchen area. seemed to be very upset. When eyes were wide. entered the living room, she was shaking and her not to leave. I asked to pray for JonBenet and to lead everyone in a prayer. I then stood near the piano in the living room and was able to watch everyone in the living room, as well as , who was still in the kitchen area.

Patsy was crying and moaning while she was with JonBenet. Patsy raised herself onto her knees, lifted her arms straight into the air, and prayed. Patsy said "Jesus! you raised Lazarus from the dead, raise my baby from the dead!" At approx. 1312 hours there had been no officer response. There had also been no response from the coroner or an ambulance. The closest phone was a cellular phone in the kitchen. This phone was located approx. 12 feet away. I quickly walked into the kitchen, grabbed the cellular phone, and returned to the area in the hallway right outside the living room. I phoned 911. I reached Dispatcher santiago. I told the dispatcher that I needed a detective response and a coroner at my location. I identified myself by my radio number, 156. Within approx. 3 to 5 minutes of this 911 phone call I made a second 911 phone call. I again reached a dispatcher whose voice $I$ did not recognize. I was transferred to a supervisor. I informed the male supervisor that I needed detective response, the coroner, and an ambulance at my present location. I gave my location as 75515 th St. I told the dispatcher that $I$ was at the scene of a homicide. Prior to making this second 911 phone call I had seen an ambulance drive slowly northbound on 15 th St ., past the Ramsey residence. At approx. 1320 or 1325 hours Ofc. Barry Weiss arrived at the Ramsey residence. Ofc. Weiss had responded to the first floor north door, located off the caterer's kitchen. Ofc. Weiss had been calling out my name. I briefly met with ofc. Weiss and then returned to the hallway outside the living room area. I informed ofc. Weiss of the current situation.

At an unknown time after JonBenet's body was found, and prior to Ofc. Weiss' arrival, I instructed to stand guard in front of the basement door. I told $\longrightarrow$ that no one was to enter the basement area. After ofc. Weiss arrived I met with the following BPD officers: Watch I Sgt. Dave Kicera, Ofc. Alaric Morgan, Ofc. Rick French, Det. Bill Palmer, and Sgt. Larry Mason. Agent Ron Walker with the FBI had accompanied Sgt. Mason. Paramedics from AMR Ambulance also arrived. After Ofc. Weiss arrived I had requested that an ambulance respond. Patsy Ramsey appeared to be swooning and I was concerned for her health. The paramedics did physically check Patsy Ramsey. The paramedics did not examine nor touch JonBenet. I was told that patsy Ramsey was obviously very distraught, however she physically did not need to have medical attention. The two paramedics cleared the scene after Patsy was checked.

At 1315 hours I received a page from communications. The page stated that Sgt. Kicera was at the front door at 875 15th St. Sgt. Kicera was unable to find me. I also received a page on my pager at approx. 1329 hours. The page stated that my cellular 911 call had been received by weld county. Weld county Communications did not understand me. I was instructed to call Boulder Communications Center if I needed assistance.

After BPD officers arrived everyone was cleared out of the living
room. JonBenet's body was left where I had placed her. At approx. 1340 hours Det. Bill Palmer told me that he overheard a phone conversation made by John Ramsey. John Ramsey was making arrangements to fly to Atlanta either that afternoon or that evening.
 Patterson. I phoned Det. Patterson using one of the cellular phones in the kitchen. Det. Patterson told me that he was going to attempt to contact and interview Burke Ramsey. Det. Patterson asked where Burke was staying. I informed Det. Patterson Burke was at the residence located at
in Boulder. family members were watching Burke. One of the family members at the house was ard.

I cleared the Ramsey residence at approx. 1435 hours. The Ramsey residence was vacated after John and Patsy Ramsey and their friends had left the residence. Officers cleared the residence and awaited a search warrant before returning. John Ramsey had been wearing khaki pants and a blue and white long sleeved striped shirt when I had last seen him. Patsy Ramsey had been wearing black pants and a red turtleneck sweater when I had last seen her. There had been a paperbag containing children's clothing which was sitting in the doorway to the den throughout most of the morning. After approx. $11 \mathrm{a} . \mathrm{m}$. I moved the bag to the cloak room area, which is located next to the door leading into the garage. told me the clothing contained outer clothing for JonBenet and Burke. Winter ski pants, two winter jackets, and boots had been contained within this bag. removed these items and placed them in the cloak room area.

When I had asked about doors being locked in the house, John Ramsey told me that the door leading from the garage into the house is always left unlocked. John further told me that the garage area is always secured from the outside. Before ofc. Weiss left the residence on the morning of Dec. 26 , I believe he opened the door leading from the house into the garage area. I briefly saw a utility vehicle and a car. Ofc. Weiss cold me that the car was a Jaguar.

After I had cleared the Ramsey residence I returned to the Boulder Police Dept. I met with Det. James Byfield and assisted him in completing a search warrant for the Ramsey residence. I also attended a general detective briefing.

When John Ramsey met with me in the living room, after JonBenet's body had been found, I asked him where he had found JonBenet. John Ramsey told me JonBenet had been in the wine cellar. John Ramsey told me JonBenet had been lying underneath a blanket. John told me
that JonBenet's arms had been tied. JonBenet had a piece of tape covering her mouth. John told me he removed the tape from JonBenet's mouth. John said he then grabbed JonBenet and carried her upstairs. One of the first things John told me after he came into the living room and had covered JonBenet's body was, "It has to be an inside job." John told me I was right, it had to be someone who knew the family. John told me that no one knows about the wine cellar in the basement, and therefore it had to be an inside job.
ofc. French briefly talked with me at the Ramsey residence after JonBenet's body had been found. Ofc. French asked where JonBenet's body had been discovered. I told ofc. French that John Ramsey said JonBenet had been found in the wine cellar in the basement. ofc. French asked me to describe this room. I had not been downstairs and could not describe it. ofc. French told me that when he did check the house, he checked the basement area. Ofc. French had not checked behind one door in the basement. This door had a latch on the top frame of the door. The door was latched. I briefly talked with after officers arrived at the Ramsey residence (after JonBenet's body had been found). I asked where he was when JonBenet's body was found. told me he was a few steps behind John Ramsey. John Ramsey had entered the wine cellar room located in the basement of the house. was not able to see inside the room because his vision was blocked by the door. heard John Ramsey cry out.

I obtained the following information from the general detective briefing held on the late afternoon of Dec. 26:

Det. Patterson had conducted an interview with Burke Ramsey. Burke Ramsey said he and the three other members of his family had attended a party held at the residence on Dec. 25, 1996. The Ramseys were at the dinner party from approx. 1630 hours until 2100 to 2130 hours. Crab was served at this dinner. John and Patsy Ramsey disciplined each of their children by talking to them. John and Patsy Ramsey do not use any corporal punishment on their children. Burke said there had been no family arguments prior to, nor on, Dec. 25.
Det. Idler talked with the houseguests who were staying at home. The houseguests told Det. Idler that John and Patsy Ramsey treat each of their children fairly. One of the houseguests did say that Patsy adored JonBenet. Det. Idler was told that an adult daughter of John Ramsey's, from a previous marriage, had been killed in a car accident approx. 5 years ago. Det. Idler had also been told that Patsy Ramsey had been diagnosed with ovarian cancer. Patsy had recovered from the cancer approx. 2 years ago. Det. Idler was told that John and Patsy Ramsey had held a Christmas party at their home on Dec. 23. Extra caterers had been hired to assist with this party.

John Ramsey had told me that he and Patsy had hosted a Christmas party at their home for their children's friends. I thought John Ramsey told me this open house had been held on Dec. 24. The children who attended the party had decorated gingerbread houses. The gingerbread houses decorated by JonBenet and by Burke had been sitting on the dining room table located just south of the kitchen in the Ramsey residence. John Ramsey told me this information after I had asked him about those two gingerbread houses. houses. had also talked with me about the gingerbread houses. had told me that patsy Ramsey was the only woman she know who would allow young children to decorate their own gingerbread houses. had also attended this Christmas gathering.

Det. Idler had spoken with $\quad$ told Det. Idler that he had searched the Ramsey house after he had arrived at the Ramsey residence earlier this morning. said he had opened the door to the wine cellar. was unable to locate a light switch for the wine cellar. did not enter the wine cellar. had said the interior of the wine cellar was dark and he did not see anything inside. said the latch to the wine cellar, located at the top of the door, was secured when he checked it. $\quad$ re-secured the latch to the wine cellar after he closed the door.

The search warrant prepared by Det. Byfield was signed by Boulder County Judge Diane MacDonald on the early evening of Dec. $26,1996$. I was notified that the search warrant had been signed at approx. 2000 hours. I responded to the Ramsey residence. Det. Barry Hartkopp and I used crime scene tape and secured the exterior property of the Ramsey residence with this tape. The crime scene tape was placed along the south, east, and north borders of the Ramsey property. The crime scene tape was also attached to the two wooden fences located on either side of the driveway located at the rear (west) of the residence, and along side the alley. BPD officers had been positioned in the alley located in the rear of the residence, and also at the front of the residence, to ensure the security of the house.

The Boulder County Coroner, Dr. John Meyers, was the first person to enter the Ramsey residence after the search warrant had been obtained. Dr. Meyers entered the Ramsey residence at approx. 2023 hours. Dr. Meyers entered through the front door. Dr. Meyers placed protective booties on each of his feet before he entered the residence. Dr. Meyers also covered his hands with plastic gloves before entering the residence. Dr. Meyers was told the location of JonBenet's body. Dr. Meyers exited the residence through the front door. Dr. Meyers told me he had examined JonBenet's body. Dr. Meyers pronounced JonBenet dead. Dr. Meyers told me he had observed ligature marks on JonBenet's neck. Dr. Meyers had noted petechial hemorrhage to JonBenet's eyes. Based on my training and experience, it is my experience that petechial hemorrhage to the
given. Dr. Meyer invited Dr. Sirotnak to examine JonBenet, particularly the trauma to JonBenet's vaginal area. Dr. Sirotnak did conduct an examination on JonBenet after the conclusion of this meeting. Det. Trujillo was going to be present for this examination.

At approx. 2130 hours Det. Sgt. Larry Mason and I met with John Ramsey at the residence. Sgt. Mason and I met with John Ramsey in an office area room located in the basement of the John residence. Other persons present in this room included: John Ramsey's brother, Jeff Ramsey; himself as an attorney and a stockbroker with located in Atlanta, GA; Dr. following information with John Ramsey for approx. 40 minutes. The

I asked to speak with patsy Ramsey. I was told by Dr. that Patsy Ramsey was too medicated to talk to anyone. Dr. had given Patsy valium.

John was told that there was a broken window located in the basement of his home. John told us that he had broken out a basement window approx. 4 to 5 months ago. This window was located in the room where the Christmas decorations were kept. The grate covering the window well to this window was not secured. John had been locked out of the house. John told us he removed the grate, kicked in the basement window, and gained entrance to the house from this window. John told us he had not re-secured the window nor had he fixed the window which he had broken.
Sgt. Mason had told John it would be helpful to our investigation if we could interview he and patsy as soon as possible. Sgt. Mason requested that we interview John and patsy on Saturday morning, Dec. 28. Dr. Beuff told Sgt. Mason he did not know if Patsy would be available for an interview at that time. Dr. Beuff said that Patsy was in a fragile emotional state and he did not want to subject her to anything which would further upset her. No definite answer was given regarding the request to interview John.
I again asked John if he could think of anyone who might be a possible suspect in this investigation. John told me that he could only think of two persons from Access Graphics who might be considered a suspect. John had previously given me the name of one of these individuals, The other person was a man who had been fired from Access Graphics approx. 3 years ago. John told me that he had talked to the person in charge of Human Resources at Access Graphics. John had asked if potential employees could be asked the question
of whether or not they smoked. John was told this question could be asked. The male employee was asked this question. The male employee stated that he was not a smoker. After the male employee was hired it was discovered that he was a smoker. John said the man was fired because he had lied on his application, not because he was a smoker. The man sued Access Graphics. The lawsuit was reported in the local newspaper. John told me that the lawsuit was settled. The former employee received a $\$ 15,000$ settlement. John said he had not received any contact from this employee after the lawsuit had been settled.

John told us that this was a difficult time of year for him. John told me that his daughter, Beth, had been killed in a car accident on Jan. 8, 1992. John also told me that this was a difficult time for Patsy. Patsy had been diagnosed with ovarian cancer two years ago. Patsy had undergone treatment and the cancer had been removed.

John Ramsey told us that he was thinking about offering a reward. John did not ask any questions about the results of JonBenet's autopsy. John told us that there would be a private memorial service for JonBenet at St. John's Presbyterian Church in Boulder on Sunday afternoon. The memorial service would be held at 1400 hours. The memorial service was not open to the public. After the conclusion of the memorial service John and his family would be flying to Atlanta, GA. JonBenet's funeral was to be held on Tuesday, Dec. 31, in Atlanta, GA. JonBenet was going to be buried next to her half-sister, Beth Ramsey. When Sgt. Mason and I left John we told him we would phone him in the morning to arrange for interviews for he and Patsy.

[^0]:    After officers had been dispatched to this call, all further communication was done by telephone rather than radio traffic. The first officer on the scene was Ofc. Rick French. Ofc. French had told Sgt. Reichenbach that something didn't seem right. The 6 year old daughter of John Ramsey, JonBenet Ramsey, had been kidnapped from her bedroom sometime between approx. 2200 hours on Dec. 25, 1996 and 0600 hours on Dec. 26, 1996. A $21 / 2$ page note had been found by JonBenet's mother. Demands in this note stated that $\$ 118,000$ be paid to ensure the safe return of JonBenet. No police or law enforcement were to be notified, otherwise JonBenet would be

[^1]:    (ind a friend of John Ramsey's, told John Ramsey that he would be able to obtain the ransom amount from his bank. left the Ramsey residence after I had arrived and met with his banker. returned to the Ramsey residence prior to about 0930 hours. told me that he had arranged with his banker to have $\$ 118,000$ in cash be available. This amount was available when returned to the Ramsey residence. The amount had been arranged in the denominations demanded in the suspected ransom note. told me he was able to get this amount obtained within approx. one hour of notifying his banker. 2nald me that $\$ 118,000$ is a relatively insignificant amount compared to John Ramsey's wealth. told me that the persons who demanded the ransom could easily have asked for $\$ 10,000,000$ and had obtained that amount.
